Capital punishment is currently authorized in 28 states, by the federal government and the U.S. military. In recent years, New Mexico (2009), Illinois (2011), Connecticut (2012), Maryland (2013), New Hampshire (2019) and Colorado (2020) have legislatively abolished the death penalty, replacing it with a sentence of life imprisonment with no possibility for parole.
